12. POWER OF BOARD OF TRUSTEES

The Board of Trustees shall have the following powers:

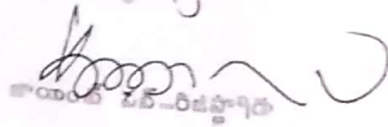
To commence, carry on any Business or Commercial activity in the course of actual carrying out of primary purpose of the Trust for augmenting the resources of the Trust provided the Net Revenue (Gross Revenue less the costs incurred in generating the Revenue from such activity) is utilized for the purpose of the Trust and not for any other purposes. The Trustees specifically consent to this obligation. This is an enabling provision for augmenting the resource of the Trust subject to Para (c) below.

To receive Donations or to treat such donations for the purpose of the Trust either towards Corpus or other funds eligible to be spent or applied according to the objects of the Trust.

To invest the funds in best possible manner but the Trust will not embark upon any speculative business or venture. Such investments will not deviate from the requirements of any law. Such power to invest includes the power to dispose of alter or vary the investments from time to time to realize the investments.

To accumulate the income for the objects of the Trust and to apply the same either out of the funds or the income for purposes of the Trust to the extent considered prudent and necessary during the year subject to any regulations governing funds accumulation under any law for the time being in force.

To open and operate one or more Bank Accounts and obtaining any loans from any banks (or) financial institutions as may be authorized by resolution of the Board of Trustees. The Board will have the power to borrow, Sign on Bills of exchange and cheques and other Bank documents and authorize for this purpose by chairman along with secretary (founder trustee) or treasurer (any trustee) to exercise such power, by a resolution.

To convert the Trust property, acquire immovable property, sell, charge, rent out or otherwise alienate the assets including immovable property for protecting or improving the Trust property or for any objects of the Trust.

To sue, defend suits abandon, submit to arbitration and compromise them in the interest of the Trust in the name of the Trust. The disputes in respect of the interpretation of this deed or during the course of achieving the object of the trust or interest disputes arising between the trustees and in the matter of election of the trustees and other persons mentioned in this deed shall be referred to the Forum of Arbitration and the Law governing the Arbitration as on that date shall be applicable.

To engage, suspend or dismiss employees or to take such other action to ensure proper Management of the Trust. The Board will have all powers necessary and incidental for management and administration of the Trust and its properties.

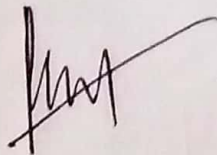
To delegate their duties to any one of themselves or to employees, Co-Trustees and committees.

To invite any Employee, Expert, Advisor, professional or well wisher to attend Trust Board meetings for advice and participation without right vote.

To appoint Advocate/s or Agent/s or to delegate such Advocate/s or Agent/s all powers vested in them and in these presents from time to time to remove such Advocate/s or Agent/s and to appoint other/s in their place.

To get reimbursed all expenses incurred by the Trustees in connection with the administration of the Trust including the remuneration for secretarial and other administrative work arranged by the Trustees and all other expenses incurred by the Trustees in or about the execution of the Trust Powers and discretions thereof.

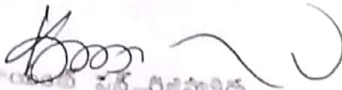

It is clarified that the power of investment of the Trust Funds including those mentioned in the clauses hereinabove shall be exercised in accordance with the provisions of Section 13 of the Income-tax Act 1961, in general and in particular shall not violate the provisions of Section 13(1) (d) read with section 13(5) of the Act so as to ensure exemption under the Act.

It is further expressly declared that no part of the Trust or its income shall be applied for any purpose which is not educational or charitable in nature and nothing herein shall be construed to authorize the Trustees to utilize the Trust assets or its income for any non-educational purpose. All the powers and provisions hereof shall be construed as being subject to restrictions, limitations, herein contained and contained in the Income-tax Act 1961 or any amendment thereof.

All Investments of the Trust shall ordinarily be held in the name of the Trust and the Trustees shall not cause themselves to be registered as the Holders of any securities constituting investments belonging to the Trust.

The Trustees of the Trust shall meet at least once a year and whenever occasion arises they may meet any number of times as they desire.

13. FUNCTIONS

Without affecting the generality of the powers and functions of the Trustees to manage and administer the Trust, the Trustee/s shall have the following functions:

To Borrow if need be with or without security against the assets of the Trust on such terms and conditions as the Board may deem fit and to execute the required documentation thereof as may be authorized by the Board in this behalf.

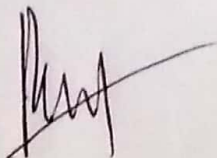
To authorize the execution of documentation on behalf of the Trust in relation to any matters of the Trust.

To appoint or make provision for the appointment of one of the Trustees or any other person as Honorary Secretary or have a Sub Committee of Trustees or have paid Secretary or any other person or persons to attend or to supervise or conduct specified jobs or functions or entrust matters in such manner and subject to such rules and regulations as the trustees may prescribe.

To authorize any one or more Trustees to hold any property or any investment of the Trust subject however to the terms of these presents in such manner and subject to such terms and conditions Rules and regulations as the Trustees may from time to time think fit and proper.

To spend, disburse funds of the Trust for any of the purposes of the Trust.

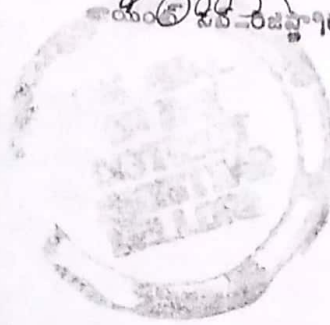
To do all such acts, deeds and things as may be deemed expedient or convenient for the administration / management of the Trust.

The Chairman shall have the power to represent the Trust in all affairs of the Trust, but the Chairman shall not take any decision in connection with acquisition of properties or on matters of vital importance in the management of the Trust without taking the other Trustees into confidence.

The Chairman shall have the power to operate the Bank Accounts of the Trust along with the Secretary (or) Treasurer.

The Secretary i.e. founder trustee shall be in charge of managing the day to day affairs of the Trust

The Treasurer shall be in charge of managing the finances of the Trust

14. AMENDMENTS TO THE TRUST

It will not be open to the Trustees to amend the objects or the terms stipulated in this indenture. If any amendment is necessary for more effective implementation of the objects, it may be made subject to the concurrence / approvals of the concerned statutory authorities.

15. NO BENEFITS TO SETTLOR, TRUSTEES

The Trustees will not be entitled to any remuneration or other benefits save and except reimbursement of expenses incurred in the discharge of their duties.

16. INDEMNITY FOR TRUSTEES

Trustees will not be personally liable for any act bonfire done on behalf of the Trust in the course of duties as a Trustee.

17. FINANCIAL YEAR

The Financial year of the Trust shall run from April to March as prescribed by law.

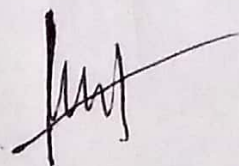
18. REGULATIONS

The Board may from time to time frame regulations for conduct of its affairs and administration of the Trust and vary, alter or substitute such regulations.

19. MEETINGS

The Board meetings will be held at least once in three months, notice of such meetings to be given at least a week in advance. Any Trustee could requisition a meeting and such requisition is to be addressed to any of the Founder Trustees who in turn shall arrange for the requisitioned meeting to be convened without delay.

The quorum for the meeting shall be Five Trustees which shall include participation by at least one Founder Trustee.

20. ACCOUNTS

Proper Books of accounts will be kept for the Trust and such Books of Accounts the Board shall be audited by a Chartered Accountant within three months from the close of each financial year and the Auditors Report submitted thereon.

21. AUDITORS

The Trustees shall appoint Auditors who shall be a Chartered Accountant to audit the Accounts of the Trust for each financial year and submit his Audit Report on such terms and conditions as to remuneration as may be agreed upon between the board and the Auditor.

22. RECORD

Apart from the Books of Accounts the Board shall cause a record to be kept of investments, disinvestments and disbursements.

In addition the Board shall maintain a Minutes book truly recording all the decisions and proceedings of the Board meeting. The minutes of each meeting shall be signed by the Chairman of that meeting or the succeeding meeting.

23. INTERPRETATION

The provisions of the Trust deed and Rules/Regulations framed by the Trustees from time to time shall be interpreted by the Trustees. Their decisions shall be final and binding on all concerned.

If any doubt arises in the interpretation of the above documents the matter shall be referred to a referee chosen by consensus among the Trustees and his decision shall be accepted.

24. DISSOLUTION

Notwithstanding Article 7 herein above, if the objects of the Trust could not be pursued for whatever reasons or it becomes necessary to wind up or otherwise determine the Trust for whatever reasons the net funds and assets, if any other similar Trust or institutions which satisfies the requirements of law, as may be decided by the trustees, provided the Trust chosen by the Trustees is an institution approved by statutory authorized concerned.
